

**MINUTES**  
**Lefors City Council Meeting**  
**April 14, 2025 - Regular Session**

The meeting was called to order at 7:00 p.m. by Mayor Michael Ray. Present were Council members Jerry Stegall, James Gee, Savannah Kingcade and Aaron Hunt. Council member Ashley Miller was absent.

Mayor Ray led the Pledge of Allegiance. Councilman Gee said the Invocation.

No citizens' comments were presented.

City Judge, Kurt Curfman, submitted a written report: For the month of March 2025, we had receipts of \$1334.00. There was 1 new complaint filed with the Court. This was for state or City Ordinance violations. At this current time, we have an outstanding balance of fines and court costs due the city in the amount of \$200.00 plus warrants of \$8,820.00. All local, state, and federal reports are current.

Public Works Director, Chad Young, reported that the 150' of water main that was grant funded has been completed on First St., the leak at the water tower is going to require the town water supply to be shut down while the main going to the tower is removed completely and the work is planned for May 19<sup>th</sup>, a 4" main leak was repaired on Tumbleweed Road, a valve has failed on a blowdown at Archie Summers and will need to be replaced, the TWDB project at the sewer plant was completed on March 21<sup>st</sup>, and the generator for the sewer plant is still in the shop and it is unclear yet if it is repairable.

Savannah Kingcade updated the Council on the activities of the Lefors Youth Sports. They are working on field improvements and are planning a fundraiser to replace the lights. Andrew Morriss has volunteered to install them. They will be creating banners to hang based on donations to make improvements in the outdoor restrooms, including new lights, toilets and updating faucets. They hope to paint the inside of the civic center before the all school reunion.

Councilman Hunt made a motion to approve consent agenda items consisting of minutes of March 10, 2025, regular meeting, department reports, and bills except for a bill received from Hydro Resources for Well #6 until it is followed up on. Councilwoman Kingcade seconded. Vote unanimous. Motion passed.

Mayor Ray signed a Proclamation declaring May 4<sup>th</sup>-10<sup>th</sup> 2025 the 56<sup>th</sup> Annual Professional Municipal Clerks Week.

Councilman Hunt made a motion to adopt Ordinance 2025-0414, an Ordinance amending City Hall hours. Councilman Gee seconded. Vote unanimous. Motion passed.

Councilwoman Kingcade made a motion to pass Resolution R-2025-0414-2, a resolution for acceptance of TWDB Project No. 73850-Wastewater Treatment Plant Facility Improvements. Councilman Stegall seconded. Vote unanimous. Motion passed.

The council went into executive session at 7:21 p.m. to discuss personnel issues.

The council returned to regular session at 7:37 p.m. No action taken.

Councilwoman Kingcade made a motion to adjourn the meeting. Councilman Stegall seconded. Vote unanimous. Motion passed.

The meeting adjourned at 7:38 p.m.
